

Wedding Photography Agreement

This agreement is between Mark Stagi operating in the State of California, (hereinafter "Photographer") and _____ (hereinafter "Client") relating to the Clients wedding that will take place on _____ .

Description of Services

The parties agree that Mark Stagi will furnish photographic services on the above date, coverage to begin and end at a time mutually agreeable to the parties. The price for this coverage is \$_____ plus California state sales tax. The Photographer shall be the exclusive professional photographer retained by the Clients for the purpose of photographing the wedding. Family and friends of the Clients are welcome to photograph the wedding as long as they shall not interfere with the Photographers' duties.

Payment Policy

A retainer of \$500 is deposited here with to reserve event coverage for the services specified above. This retainer is non-refundable upon cancellation of the event. Should the event be canceled within 30 days prior to the date of the event, all payments are accelerated and are due and payable immediately. Payments for additional items or coverages made prior to the wedding will be reserved and applied to the costs at the time of purchase. Another 1/2 of the balance is due 30 days before the event, and the remainder is due at the time of the performed services.

Product Pricing

Pricing is defined on the Photographer's standard price list in effect at the date of this contract. Prices quoted for professional services, photographs, and albums are guaranteed for a period of six months following the date of the wedding. Orders placed after six months following the wedding are billed at the rates in effect on the most recently published price lists.

Limitation of Liability

While every reasonable effort will be made to produce and deliver outstanding photographs of the wedding events, the Photographer's entire liability to the Clients for any claim or loss arising from the Photographer's performance is limited to a refund to the Clients of the amount paid for services. Because a wedding is an uncontrolled event, The Photographer cannot guarantee delivery of any specifically requested image(s). In the unlikely event of personal illness or other circumstances beyond the control of the Photographer, a substitute photographer of high qualifications, subject to acceptance by the Client prior to the event, may be sent to fulfill the obligations of the Photographer herein contracted. In such case that the Client declines the substitute photographer, the Client may instead terminate this agreement and receive a full refund of all moneys paid.

Copyright & Usage

Proofs and previews (digital or traditional) shall be delivered to the client no later than 4 weeks following the date of the wedding. The Photographer shall retain copyright in all

images created and shall have the right to make reproductions. The Photographer shall only make reproductions for the Clients or for the Photographer's portfolio, samples, or self-promotions. The Photographer shall not make reproductions for other use without first obtaining the written permission of the Clients. The Client is obtaining prints for personal use only, and shall not sell said prints or authorize any reproductions thereof for other commercial use. Negatives will be given to the client approximately 6 months after the wedding date at no additional charge. The photographer reserves the right to keep up to 10 negatives of the Photographers choice to use only for portfolio, samples, or self-promotions.

Agreement

This Agreement incorporates the entire understanding of the Parties, and the Parties agree to all its terms, and acknowledge receipt of a completed copy of the Agreement signed by all Parties. Any modifications of this Agreement must be in writing and signed by all parties. Each person signing as Clients(s) below shall be fully responsible for ensuring that full payment is made pursuant to the terms of this agreement. This Agreement shall be governed by the laws of the State of California.
